Re: Freedom of Information Determination

I refer to your Freedom of Information application received by the Office of the Minister for Education on 5 November 2018, seeking:

I understand that this office confirmed with [REDACTED] to update the date range of this application from 22 May 2018 to 5 November 2018.

Searches have been conducted for information in relation to your request. Three documents were located that have been identified as matching the scope of your application. I have considered the document, with reference to the *Freedom of Information Act 1991* (FOI Act), and have determined to release the document in full with out of scope information removed.
