## **RE** Freedom of Information - Determination

I refer to your Freedom of Information application which the Department for Education received on 1 March 2021, seeking access to:

'Documents showing project management costs contracted to Sensum Group for project management of 12 school site upgrades.'

The department has interpreted the '12 school site upgrades' as referring to the 12 initial projects included in the accelerated modular accommodation program, which Sensum has been contracted to program manage.

Searches undertaken in relation to your request have identified one document. Sensum have been consulted with regard to release of the document. I have considered their submission and have determined to release the document in full as Document 1 attached.

Please note, the figures listed in the table represent 100% of the project management fees for Sensum, for each of the 12 capital work projects.

No costs have been levied for processing of your application as they are within the threshold prescribed by the Freedom of Information (Fees and Charges) Regulations 2018, allowed for Members of Parliament.
