RE Freedom of Information - Determination

I refer to your Freedom of Information application which the Department for Education received on 3 March 2020, seeking access to:

'Postal addresses for all family day care providers in South Australia'

Searches were conducted for information in relation to your request. There were 2 documents identified as matching the scope of your application. I have considered the documents with reference to the *Freedom of Information Act 1991* (FOI Act) and have determined to exempt 1 document in full (Document 1) and release 1 document in full (Document 2).

A detailed explanation of the specific clause relied upon is set out below.

Clause 6(1) - Personal affairs

I have determined that document 1 exempt from release in full contains personal information concerning persons other than you. Family day care providers are small businesses that register with the department to deliver education and care in their own homes. Therefore, the disclosure of their postal address, which in the main refer to their residential address would be unreasonable because the nature of the information is confidential to those persons and the likelihood that those persons would not want the information to be disclosed.

This information falls within the definition of personal affairs under the FOI Act; therefore, the information is exempt by virtue of Schedule 1, clause 6(1) which provides that:

6—Documents affecting personal affairs

- (1) *A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead).*

No costs have been levied for processing of your application as they are within the threshold prescribed by the Freedom of Information (Fees and Charges) Regulations 2018 allowed for Members of Parliament.

If you are dissatisfied with this determination, you are entitled to exercise your right for an internal review in accordance with section 29(1) of the FOI Act. To make an internal review application, please complete an application for Internal Review which can be downloaded from <https://www.education.sa.gov.au/departments/legal-services/freedom-information-foi-requests>. Alternatively an application may be made in writing, addressed to the Principal Officer of this agency and must be accompanied with the appropriate fee (if applicable). This application must be lodged within 30 days from the date of this determination. Applications for review can be sent to education.foi@sa.gov.au.

In accordance with the requirements of Premier and Cabinet Circular PC045, details of your FOI application, a copy of your notice of determination, schedule of documents and the documents to which you are given access, may be published in the agency's disclosure log.
