RE Freedom of Information - Determination

I refer to your Freedom of Information application received by the Department for Education on 2 October 2018, seeking:

'Access to the data relating to the overall number of reported bullying and harassment cases within the Department for Education over the past 10 years and the number of days lost through victims of bullying and harassment being absent from work.

Specifically, I request the following information:

- The number of reported cases of bullying and harassment within the Department for Education for each of the past 10 financial years (2008/2009 - 2017/2018).
- The total number of staff employed by the Department for Education at the end of the financial year for each of those 10 years, both by total headcount and total full time equivalent (FTE).
- The number of Department for Education employees who have lodged workers compensation claims, and the number of claims that have been accepted, as a result of bullying and harassment in the workplace for each for each of the past 10 financial years (2008/2009 - 2017/2018).
- The number of lost time injury (LTI) days experienced due to bullying and harassment claims for each for each of the past 10 financial years (2008/2009 -- 2017/2018).'

Searches have been conducted for documents in relation to your request. Three documents have been identified as matching the scope of your application. I have considered the documents with reference to the Freedom of Information Act 1991 (FOI Act) and I have determined to release them to you in full.

It should be noted that the number of reported cases citing bullying and/or harassment do not correlate with the number of workers compensation claims.

In accordance with the requirements of Premier and Cabinet Circular PC045, details of your FOI application, a copy of your notice of determination, schedule of documents and the documents to which you are given access, may be published in the agency's disclosure log. Exclusions

- Reports for Families SA are not included in the count

Qualifications

- The department does not have a central data base that specifically records bullying and harassment reports.
 Information is held in case management systems.
- One count in 2014-15 and one count in 2017-18 involved combined complaints from multiple parties against a single person. These matters were managed as a single report and are counted once.
- Three cases in 2017-18 involved a complaint against a single person and each complaint was lodged separately. A
 count of three is recorded.
- There are instances where a single person has made multiple complaints over a number of years. A count has been
 included for each separate complaint.
