Terms of Reference

2023 to 2027 National Student Wellbeing Program Cross Sector Panel

Background

The 2023 to 2027 National Student Wellbeing Program (NSWP) provides funding for schools to support the wellbeing of students through a pastoral care or wellbeing service.

The NSWP is funded by the Australian Government and administered by states and territories. The 2023 to 2027 NSWP project agreement is the instrument by which the program is funded. The project agreement requires that each state and territory establish a cross sector panel.

Purpose

In South Australia, the Cross Sector Panel acts as the decision maker for the day-to-day administration of the program to ensure compliance with the terms of the 2023 to 2027 NSWP project agreement.

This includes:

- selecting and prioritising schools for funding in their jurisdiction
- coordinating the implementation of the NSWP in their jurisdiction
- coordinating requests for information from the Australian Government
- reporting on the delivery of the NSWP to the Australian Government
- sharing of appropriate cross sector information in the implementation of the NSWP, and
- assessing requests for transition to minimum qualifications for pastoral care workers or wellbeing support officers.

Term

The terms of reference are effective from 1 January 2023 and will be ongoing for the life of the 2023 to 2027 NSWP project agreement or until terminated by agreement between the parties.

Proxies

Members of the Cross Sector Panel can send proxies to meetings. Proxies must have sufficient authority to contribute to discussion and represent their sector in panel discussions.

Members of the Cross Sector Panel can bring additional persons to meetings with notification to the Executive Officer prior to the meeting. Additional persons do not have decision making capacity.

Meetings

The cross sector panel will meet a minimum of twice a year to collaboratively discuss the administration of the NSWP. Additional meetings of the cross sector panel will be negotiated and scheduled as the need arises or as requested by panel members.

Meeting agendas will be prepared and distributed by the Executive Officer. The Executive Officer will request items from the cross sector panel for inclusion in the agenda.

The decision of the panel will be made by consensus where possible. If a consensus cannot be reached, the decision will be referred to the Minister for Education.

The cross sector panel will also consider information out of session via telephone or written correspondence. Significant matters dealt with outside of the meeting will be reported on at the next meeting of the cross sector panel.

Minutes of each meeting will be prepared by the Executive Officer and distributed to the cross sector panel for confirmation.
